WISCONSIN STATE PATROL ALUMNI ASSOCIATION, INC. FORMED

Over the years you have individually and collectively expressed a need and an interest in developing and maintaining a linkage between the past and present in the State Patrol. Maintaining communications and social interaction with employees you served with during your active service days and by some of those who are still serving today was requested. You also expressed a concern about historical documentation and the need of collecting, protecting and displaying memorabilia. At the Academy Alumni Luncheon last year, we asked, "Should we pursue the formation of an Alumni Association which would be separate and apart from any existing association to perform these tasks?" The response was an almost unanimous, YES! And over one third of the responders signed up to actively support the effort.

In answer to your desire, the Wisconsin State Patrol Alumni Association, Inc. (WSPAA), a non-political; non-profit; non-union; non-stock corporation has been created. The purpose of the association is to maintain the heritage and traditions of the Patrol, provide a mechanism for social and fraternal interaction, and communication between its retired and active employees. Communications will be established between the WSPAA and program administrators in the development and furtherance of programs that enhance police professionalism, highway safety, and service to the motoring public. WSPAA membership is available to all former and current Communications personnel, Troopers, Inspectors and non-sworn support staff.

In more contemporary terms, WSPAA, through liaison with State Headquarters and other State agencies, will periodically publish newsletters informing members of current or pending changes in personnel, departmental policy, organizational structure and technological advances in police sciences. We will monitor pending changes in the retirement system, health insurance and pending legislation. Members/subscribers will be encouraged to contribute news articles of present day happenings and reminiscent anecdotes from the past. We plan to have regional representatives across the State to help in the gathering of information and the coordination of WSPAA efforts. A web page for the Association is also planned as a future project.

A dedicated task force has been at work for nearly a year to get this effort started. By-Laws have been promulgated and adopted. The WSPAA has been approved as a non-profit corporation under State Law. A Board of Directors has been seated. A budget has been developed and a dues structure has been established. A membership drive is ready for launching and this first issue of the Association Newsletter is being distributed electronically. As the WSPAA grows we will evaluate the addition of printed news material.

MEMBERSHIP

There are three categories of membership: Full Membership, Associate Membership & Honorary Membership.

Full Membership: Any retired member or current employee (sworn or non-sworn) of the Wisconsin State Patrol who has successfully completed their initial probation or has honorably terminated his or her employment with the WSP is eligible to be a full member of the WSPAA.

Associate Membership: Available to members of other law enforcement arms and persons who have displayed an interest in, performed a service or made a contribution to the general betterment of police services and to the Wisconsin State Patrol. Associate Members will be nominated by an active member and approved by the Board of Directors. Dues for an Associate Member are the same as for a Full Membership. Associate members have no voting rights.

Honorary Membership: An Honorary Membership is mainly ceremonial and is granted to any person or organization which is deemed by the Board Of Directors to have contributed substantially to the goals and purposes of this association. Potential Honorary Members may be submitted by any active member and approved by the Board of Directors. There are no dues for an Honorary Member. Honorary Members have no voting rights.
