Converting Your Group Life Insurance To Pay Health or Long-Term Care Insurance Premiums

Recently, this item (copied directly from the website) was found on the Employee Trust Fund webpage. I do not know if everyone else already knew this or if I was absent from school on this day. Either way, it seemed like something that may be of interest to some alumni. IF this is something of interest to you, contact the ETF for clarification or question. Don't be afraid to ask the specialists at ETF. It is your retirement account. This article reads:

"Active employees age 70 or older and retirees who are insured under both the Wisconsin Public Employers Group Life Insurance Program and one of the health insurance plans or long-term care plans offered by the Department of Employee Trust Funds can elect to convert their life insurance to pay health or long-term care insurance premiums. The health insurance plans offered by Employee Trust Funds are the plan available to state employees, the plan available to employees of local government employers who elect to participate in our health insurance plan, and the Local Annuitant Health Program. Long-term care plans are offered by ETF to state employees only. You cannot convert your life insurance to pay the premiums for any other health or long-term care insurance coverage.

To be eligible, your basic life insurance coverage must be at its final reduced amount. If you are retired from the state you must be at least age 66, and if you are retired from a local government employer you must be either age 66 or 67, depending on whether your basic life insurance coverage reduces to 50% or 25% of the original amount after retirement. If you are retired from the state your sick leave credits must be exhausted before you can convert your life insurance to pay health insurance premiums.

If you elect this conversion, your life insurance coverage will be converted to credits equal to the present value of your life insurance. The present value ranges from about 45% to 80% of the face amount, depending on your age. Your converted life insurance credits will be used to pay your health insurance premiums until the credits are exhausted. You cannot receive any direct cash payment.

You may file the election to convert your life insurance at any time, and it will become effective on the beginning of the third month after we receive it. The brochure Converting Your Group Life Insurance to Pay Health Premiums (ET-2325) provides detailed information on this subject." ETF Governing Board Information

Have you ever wondered who makes the decisions of the ETF? What are the governing Boards discussing at their meetings? Here is a little information to find these and other answers.

There are five Boards of Trustees associated with the Wisconsin Department of Employee Trust Funds (ETF). The Boards set policy and review the overall administration of the benefit programs provided for state and local government employees. Board membership is set by state law. Members attend meetings in Madison and influence ETF's direction by voicing member concerns, identifying ways to improve service to participants and employers, and prioritizing available resources to meet competing administrative needs. The five Boards are:

Employee Trust Funds Board; Wisconsin Retirement Board; Teachers Retirement Board; Group Insurance Board; Deferred Compensation Board.

WHERE ARE THEY NOW by Bruce Bishop

Retired Sergeant Don Jones (7th Recruit Class) was 31 years old when he joined WSP in 1958. Twenty one years later his twenty year old son Tom (28th Recruit Class) pinned on his badge. Don retired as a District #3 Sergeant in 1982 after 28 years of service. Tom retired in 2011 with 8 days short of 33 years of service. A combined 60 years of public service. Sgt. Jones is one of the charter members of WSPAA with a membership date of Sept. 2011. Trooper Tom Jones joined the WSPAA two months later.

Don is remembered by those who worked with and for him as a "no nonsense" dedicated law enforcement professional with a good sense of humor. He tells a funny story of a faultless driving record blemished only by a bull that broke loose from a cattle barn and pushed a trailer into his unmarked cruiser, several times. A few months later, he had his unmarked cruiser parked by the barn in his yard when a wind storm blew a barn door off the track and onto the cruiser.

Today Don lives alone, his wife of 30 years, Alberta, mother of Tom and four siblings died in 1984. He makes Wild Rose home during the summer and winters find him in Lakeland, FL. A nagging shoulder problem and broken vertebrae have forced him into an ALF temporarily. His current address is Rosemore Village, 830 High Street, Wild Rose, WI 54984. He'd enjoy hearing from old acquaintances.

Tom served most of his years in the Wausau District living in Tomahawk, WI. Tom also served as a pilot for many years. Tom and wife of 25 years, Cheryl, still live in Tomahawk. They have two children.

In 2003, Tom received National Police recognition when he was awarded the Medal of Valor at an IACP presentation in Philadelphia. Tom's astute observation of a 3-M reflective license plate led to the apprehension of a fleeing felon wanted for and convicted of murdering his wife.

Aside from serving as a Bishop in the Church of Jesus Christ of Latter-day Saints. Tom is pursuing a second career in driver education.
