### WSPAA HAS A SUCCESSFUL YEAR By President Bill Harvey

As 2012 comes to a close, I am happy to report the WSPAA had a very successful year thanks to over 175 members.

Our Vision is ..."the promotion of fraternal activity, preservation of history, and the sharing of information amongst the current and former employees of the Wisconsin State Patrol." This, like the "Vision" of any organization is an ongoing effort. Let's summarize some of the accomplishments.

The WSPAA has a regularly distributed "News Brief" and WSPAA Quarterly to keep our members informed. We have partnered with the Division of State Patrol to receive their weekly reports of activities and with the WI DOT to receive their weekly bulletin. We have also developed a new network among current and past members to report significant social events across the state.

The work on that effort is just beginning.

### A CHAT WITH THE SUPERINTENDENT

As the end of 2012 approaches, I had the opportunity to sit down with Superintendent Stephen Fitzgerald to discuss the status of the Division of State Patrol (DSP) and plans for the future. As any other state agency, the DSP does not control the budget, budget process, the facilities they occupy or statewide policy regarding many issues. The DSP makes proposals and justifications in the statewide budget process for what they see as needs, wants and desires to fulfill their mission.

Question: As the end of 2012 approaches, what do you see as the success stories this year?

**Response:** We had a very busy year. We have had a huge turnover with the retirement of very competent senior leaders and staff. We have been able to make promotions, reassignments and reorganization with people who have been nurtured and made ready for these positions over the years. The organization has a long history of preparing future leaders. This allowed the DSP to continue successfully as people left the organization. This is a sign of a successful organization.

We did have a major part in security at the Capitol protests, along with many other agencies. We were able to successfully meet the challenge because of our planning and training for situations like this. By working and training with other agencies, it is easier to work together when these situations arise.

We were also able to upgrade the mobile data computers and the Communications Centers this year. This is a major effort in interagency communications and to keep our personnel at the leading edge of technology at the street level.

**Question:** What is the current authorized strength of the DSP?

**Response:** By statute, we are authorized up to 401 in the trooper ranks (400 + the Supt). The inspector ranks are currently limited to 112 positions, by budget.

The DSP ran a recruit class in 2012, the first class in 3 years. Every person who graduated has been deployed into a permanent position number.

The DSP currently has 22 trooper, 7 inspector, and 1 management vacancies. With pending retirements that traditionally occur near the end of the year, there will be additional openings within the next short period of time.

The DSP is working on budget requests to include another recruit class for 30 troopers and a recruit class for 20 inspectors over the next two fiscal years.

While support staff positions do occur, the DSP is able to justify and fill these positions through transfers and hiring as they occur.

**Question:** In recent years, specialized units such as the Technical Crash Reconstruction Unit, K-9, HIDTA and Dignity Protection have been established within the authorized staffing number. Do you foresee any additional units like this being formed?

**Response:** No additional specialized units are planned at this time. We continually re-evaluate these units to be sure we are utilizing the staffing to meet our mission and purpose. We may modify a unit as needed.

The Technical Crash Reconstruction Unit is very busy. We are asked by city and county departments to reconstruct crashes regularly. We are also asked by other agencies to computer map crime scenes on a frequent basis.

The K-9 program has been very successful. The DSP has a person in training now to become a trainer of handlers. The DSP plans to train K-9 handlers for the DSP and other agencies soon.

The Dignity Protection Unit has been expanded. Times have changed and our protection services have changed. We not only protect the Governor and Lieutneant Governor, we also provide protection for dignitaries from across the country and world who visit our state.

Question: What do you see as the direction and issues for the DSP in the next 2 - 5 years?

**Response:** The WI State Patrol is primarily a rural traffic law enforcement agency. We enforce traffic laws every day. We investigate crashes. We are continually trying to reduce crashes and fatalities. We provide education to drivers in many different forums. The Bureau of Transportation Safety, now part of the DSP, works with many groups and organizations to promote this message.

The WI DOT works on roadway design, marking, signing and education to reduce crashes.

This is a team effort.

#### CHAT WITH THE SUPERINTENDENT (continued)

The Academy is a very valuable resource for law enforcement training. We are working to have other state agencies conduct their training at the Academy. The Department of Natural Resources has conducted their recruit training at the Academy for many years. In recent years, they have held their in-service there as well. The Division of Criminal Investigation (DCI) has conducted several programs at the Academy. The Department of Corrections is studying the possibility of holding some in-service and manager training at the Academy.

The Academy is also host to many meetings held by other state agencies.

The goal for the next few years is to continue the growth in utilization of the Academy to other groups.

**Question:** What do you see or would you like to see of the WSPAA participation during the 75th anniversary in 2014 and the planning leading to that milestone?

**Response:** The DSP has not started the planning for this in earnest yet. We need to get serious about this very soon. With the limited staff we have, we just have not pushed this to the forefront yet.

I want the WSPAA to be involved as much as they want to be. Many alumni have strong positive memories of their time with the DSP. They are the historians of the DSP. Many have memorabilia of those days and we need to provide some means to share that.

With the major events we conduct each year, such as inspecting all school buses and other special events, we do not have the staff time to complete all that needs to be done. The alumni members lived the history. They are the living historians.

The DSP will be moving forward on this issue soon.

This is just a short summary of the status of the DSP today. Many of the things the DSP is involved in are foreign to those of us who served many years ago. It is amazing how things change in such a short time. The DSP today is truly a 21st century law enforcement agency.

Thank you to Superintendent Fitzgerald for taking the time for this interview, his support and openness. The DSP continues to progress and shine.

#### SOME FACTS ABOUT WISCONSIN "MUNICIPAL" LICENSE PLATES ERA 1965 by Terry Stewart

1) Double star 1 and 2 were issued to the Governor's two vehicles.

2) Star plates 3 through 3000 were issued to "municipal official" (cops,etc.)

3) Municipal 3001 through 4000 were reserved for State Patrol vehicles; however the license plates were never physically produced.

4) 4001 through 5000 were reserved for municipal cycles.

5) 5001 to the end were issued to municipalities for non law enforcement vehicles (cars, trucks, road graders, etc.).

6) The State Patrol had its own license plate design and freely swapped those plates around from one vehicle to another. The vehicles bearing these plates were actually registered with a three thousand series municipal plate that was never physically produced. This was the only license plate used in Wisconsin that was not established by statute. The numbers on the plates generally corresponded to the officer's radio call number. The radio call numbers also were generally indicative of the State Patrol District to which the officer was assigned.

In 1963 Officer Fran Vickerman crashed his 1963 Chevy patrol car while in a high speed pursuit on I-90 in the City of Janesville. His vehicle went off the highway and dropped onto Ruger Avenue which crossed below. The Janesville PD completed a very thorough accident report. The wreck had been removed to Harrison Chevrolet's storage facility awaiting disposal. The Janesville police officer called State Headquarters on the recommendation of Sgt. Maynard Stoehr. He found that he had not recorded the license plate number at the scene and when he went to view the wreck, the plate had been removed. He then ran a VIN check which returned the strange license number which he knew was not on the vehicle at the time of the accident. Some lengthy explaining followed.

(Note: In 1965 the title State Patrol Trooper did not yet exist)

# WHERE ARE THEY NOW by Bruce Bishop

Have you ever wondered what happens to old Trooper pilots when they take off their badges and unpin there wings in retirement? Well, most of them just keep on flying, but now for fun. Bill Plendl is one of them. Bill graduated in the 4th Academy Class, badge #229. He is a pioneer contributor and innovator in the early days of using airplanes in law enforcement.

Following service as a combat infantryman during the Korean War, Bill joined the Patrol in 1956. This is the same year he got his private pilots license. But it wasn't till 1962 that he joined Bill (Skip) Walker and Lewis Beyer as one of the first three State Patrol air enforcement program (AEP) pilots.

The State Patrol first utilized a leased Cessna 150, high winged airplane. Later the state purchased Cessna 172's. Bill hovered over the highways of District One and other areas working with hundreds of different ground troopers on the ground, not only in speed enforcement but also in searching for lost persons, apprehension of fleeing violators or escapees, spotting traffic congestion, aerial photography, detecting overloaded vehicles, and in one instance spotting a litterer and having him apprehended.

Bill retired in 1987 after 31 years of state service . Not counting a forced landing on I-94 and a couple of aborted take-offs, his flight career was incident free. He logged over 8,500 hours of flight time while on duty. Besides flying, some of Bill's other hobbies include woodworking and Canadian fishing.

Bill married his Betty in 1955 and they had five children. His son, Kevin, followed in his father's law enforcement footsteps becoming Chief of Police in Waunakee. A grandson, Matt, State Patrol Academy Class #55 is a Trooper in the De Forest Post. Grandson Nick serves on the Fitchburg PD.
