

Upon retirement, he took a position with the Chippewa Valley Technical College and ran the Police Certification Program for 15 years.

He is survived by his wife, Jill, his sons, Andy and Mike (Gilda), and his granddaughters, Hannah and Bianca, who he dearly loved. 

#### Wisconsin State Patrol Alumni Association Board Meeting

# Thursday, June 14, 2018 at 10:00 AM District 4, WAUSAU

The meeting was called to order by President Lindemann at 10:00 AM.

#### PLEDGE OF ALLEGANCE -

After which Phil suggested we observe a moment of silence for the passing of Trpr Jorge Dumas

#### AGENDA -

Kim said Insp. Gary Koski will be here at 11:00 with information and a shadow box that is presented by the WSP Honor Guard to the officer's family at a funeral.

Scott said that he had sent out the agenda and the one thing we really need to work on is the annual meeting agenda, etc. on September 14<sup>th</sup>, at the WSP Academy at Fort Mc Coy.

Mary said her brother John called her about the planning for the annual meeting. The meal price should still be the same at \$10.00. We all agreed that we will pay for the meal of active WSPAA members no matter the cost.

#### SECRETARY'S REPORT -

Gary said our mailing of the quarterly newsletters had been staying around 17 members, however with this current print out of the membership today it is down to 14. Also, the mail for Mary Ausloos-has been returned "unable to forward" so we will have to find out why. The staff listed as "honorary members" on this list receive the information via email therefore I do not send them anything by USPS as they are covered in our group mailing.

#### FINANCIAL REPORT -

Treasurer Linda Woldt reported that there is \$14,588.32 plus two membership renewal checks she has. We were at \$14,704 last year, we have dropped a number of members who have not renewed. Mary said there were 15 from last year.

We had a discussion on how well the entry and registration went last year at the annual meeting and we will continue with the same program with a few tweaks here and there. There were only a few no shows last year.

Mike has WSPAA hats in various colors for door prizes. After check in we will pull the names of the winners so everyone is included. To save time we will pull the names from those registered and announce the winners during each break in the meeting – there should be three breaks and we can announce five winners at each one. Motion as above, second by Ray, passed.

#### **COMMITTEE REPORTS -**

#### Membership -

Mary said 15 people have been taken off the membership list for non-payment of dues. We are down to 261 members. At one time we did break the 300 mark but that was because we were carrying non-paying dues members for two years.

There was a lengthy discussion on how to reach WSP employees who are retiring and also to let current employees know they do NOT have to be retired to be a member of the WSPAA. We considered various methods such as providing our brochure that is on our website in their retirement packet. Another possibility is to contact each region that produces their Green Sheet every week and get approval to add just a line or two as a footer or a header giving our basic WSPAA information such as,

"If you are thinking of retiring and have any interest, contact the WSPAA to keep in touch!" And provide them with our contact information.

Phil and Kim said we could present the same information to the WTA.

Linda said we have 262 members right now. Kim asked if we are going to use the same renewal form for retirees that we used last year at the annual meeting. Linda will tweak the form as necessary especially noting that if a member is paying for more than one membership they need to send a separate check for each one.

Discussion followed covering applications, what the Academy did previously, the spread sheets and name badges that we used last year and recognition of previous WSP classes sworn and non-sworn personnel.

Mike will recognize the 50<sup>th</sup> and 60<sup>th</sup> year graduation classes; Leo Sendelbach was the only one in the 60<sup>th</sup> class. Phil was in the 50<sup>th</sup> which was a double class that year. Scott went over the non-sworn and asked Mike to send the 38 names to Kim with email addresses so we could send them a questionnaire. Kim will put it in a group mailing and it is up to them to respond to the questionnaire.

#### **REGIONAL REPS -**

Ray said that they just had a coffee Tuesday in Merrill and about 12 showed up: quite a few law enforcement, DNR, but only three from the WSP. He is trying to recruit more active people to become involved.

Mike said we had a very good turnout at the Green Lantern. There were two grandparents with their grandkids plus Bob White was there from Arizona.

We discussed the dedicating of a bridge and/or highway or even the possibility of something in our rest areas dedicated to our fallen law enforcement officers. Ray said the signs would only cost \$600-700.00 and talking to various individuals they recommended that instead of asking for approval of one sign at a time, do all seven so they only have to discuss it once and approve them. Now is a good time to contact

our legislators because they will be out campaigning for re-election and this is a feel-good situation and they would play ball with us. DOT did say they won't allow them on bridges as they may fall off injuring someone however, their sign shop certainly would be capable of producing any signage we may want. The WTA also has their own lobbyists and looking at doing stretches of highways but they don't have anything rolling yet. We would try and get the WSPAA and the WTA working together on this project.

**INSP. GARY KOSKI** of the WSP Honor Guard arrived for presentation and answer questions regarding the flag boxes that we present at funerals. Each has a Wisconsin state flag inside. The wooden flag box has an engraved metal plate which reads,

#### "WHEN ONE FALLS, IT IS FELT BY ALL"

and there is a WSP emblem on the back.

Some of the questions and answers from the presentation:

**Who are they presented to** — we were all surprised that the flag box memorials are only presented to fallen officers of Wisconsin state agencies, not county, city, etc. The Honor Guard tries to go to all State Patrol/Police funerals and larger events such as the six that died in Dallas. However if an agency does not want us there, we do not go.

**How long has it been in effect** – to the best of our knowledge it began in 1996 and Trevor Casper was the first line of duty death that really got things going. He did more for our organization in getting this all in motion. Before Trevor we had an Honor Guard but we were sort of on our own and not recognized as it was in 36 other states. Usually there are 30 some state agencies represented at funerals, at one funeral there were 42 states represented. Originally if there was a funeral in Wisconsin or the surrounding states, we would attend but there were a lot of hoops to go through. Trevor's passing showed management how important it was plus with the influx of people and representatives, these critical incidents are overwhelming. A lot of people did not know the WSP had an Honor Guard and for some time we were floundering and many people were not recognized in the past.

**Cost** – Each flag box is \$20.00, the Wisconsin flag is \$12.00 and the engraved plate is \$12.00, total \$44.00. They have been looking at other options to try and keep the cost down. Insp. Koski said that he will have Sgt. Rob Hartson get the figures to us so we have an idea of what we are talking about.

**Availability** – Currently there are about ten flag boxes at different posts to try and cover each situation that may come up.

**Overnight shipping** so it arrives in time for the funeral – the cost can easily be anywhere from \$75.00 to around \$250.00.

**Possible Replacement** – Insp. Gary passed around a picture of a wooden plaque in the outline of the State of Wisconsin; it has a medallion - such as a challenge coin - inset in the upper left corner of the plaque. These are flatter and easier for the Honor Guard to include in their luggage when they travel to a funeral. They could engrave anything on the flat wood surface and it would eliminate any damage as experienced with the flag boxes.

**Our participation** – we discussed the possibility of making a donation but decided we do not have enough information at this time.

**Positive response** – The family members greatly appreciate having the WSP there and the person doesn't have to be with the State Patrol at the time of death. It has been an overwhelming positive experience and Insp. Koski said he hasn't heard anything negative.

On the subject of the WSP Honor Guard, if any retiree wants a representative of the Honor Guard, at least one is sent to the funeral, sometimes two. Hopefully one of them knew the officer or family. If we don't contact the WSP, Sgt. Rob will make the contact as it has never been offered in the past plus there are some that do not want the WSP there.

Kim said she put in a group email to all members about a month ago regarding the passing of a family member that they have to make the contact with the WSP for the Honor Guard. Scott said we have a lot more to talk about.

Insp. Koski returned later with additional information on the flag boxes. In 2015 the Honor Guard went to four in state funerals and 12 out of state. When they started they gave flowers as Honor Guards. The flag box came up in 2016 and we did three in state and 15 out of state funerals. In 2017, two in state and 15 out of state which is an average of 18 funerals a year. So far this year it has been one in and two out of state. The WTA has set aside an account for the Honor guard that helps pay for other things that the state would not pay for, gas for our bagpiper Kevin Lynch and anything else Honor Guard related. Rob or Ryan can answer any more questions. He concluded with for any line of duty death of any state agency, we give the flag boxes.

#### ANNUAL MEETING PROPOSED AGENDA -

Election of officers, we need to re-elect the President, Secretary, the NW and SW Region Reps. Our bylaws state we have to re-elect the Reps even tho they are an appointed position and at times we have problems filling the slots, the NE Regional Rep is still an open position.

Deceased Trooper Mark Lewis' wife Cris Lewis wants to help out at the academy and she has all the Regional Rep description information, etc. Presently she is an honorary member but is very interested in joining us and help wherever she can. Linda said per Section 6 of the By-Laws, it does not limit the amount of Regional Reps.

Regarding the by-laws, Maynard Stoehr brought up the subject at the WSPAA breakfast at the Green Lantern and we concluded that we can now disband the By-Law Committee; motion so moved by Linda, second by Kim, approved.

Phil said it would behoove us to meet again for half a day at one of the posts before our annual meeting. Linda said we should do as we did last year at a special August meeting. Gary asked with our present day electronic communications, etc. — could we do it by email or telecom? The consensus is that we need to get together in person as sometimes the emails get lost and/or confusing so it was agreed to get together again in August. A number of locations were brought up and Gary said while working for different departments at the WSSOB at 1 West Wilson, many of them conducted almost quarterly meetings and they considered a motel at the first Stevens Point exit (northbound I-39) to be the center of the state for all their meetings. Ray said he would do some checking with the county sheriff and police department to see if they would have a room available and let us know.


