Happy Birthday to the Wisconsin State Patrol Alumni Association! The WSPAA is <u>ten years</u> old. The Association was founded by a group of retired WSP employees. Their vision was to keep their fellow retirees informed of what the WSP was doing and to support the Agency. We have tried to meet their vision by providing weekly reports, which include the "green sheets" (weekly memo) and the Monday table top reports (weekly review). We have assisted the WSP in identifying and categorizing the thousands of photos and memorabilia for the 75th Anniversary in 2014. We took over the planning, organizing, and paying for the member's lunch at the Academy on Alumni Day. We have also given the Honor Guard a \$1000 cash donation and we have started a program where we will give two \$1000 scholarships.

We have accomplished many things in our ten years, but we need to improve in one area.

We are still in need of Regional Representatives. The WSPAA Board should consist of the president, vice-president, secretary, treasurer, and two representatives from each region. We



need two representatives for the Southeast region, one for the Southwest region, and one for the Northcentral region. The duties of a regional representative are as follows:

- Function as a liaison between the WSP Commanders and the WSPAA members.
- Advance the directives set forth by the Board of Directors and the WSPAA by-laws.
- Monitor local news outlets for information that would be of interest to the membership, and forward such information to the appropriate person for possible inclusion in the weekly or quarterly newsletters. An example of information to be forwarded would be: activities of WSP or WSPAA members that are positive in nature; the death or illness of a WSP or WSPAA member.
- Attend regional gatherings and submit a short report for the newsletter
- Attend WSPAA Board of Directors quarterly meetings and provide a summary of regional activities.
- Promote the WSPAA and encourage membership for eligible prospects to join the Association

The duties of a regional representative are not difficult, nor are they all that time consuming. I would hope out of our 263 members someone from the regions where there are vacancies, would step up. If you care about the Association and would like it to continue then please consider becoming a member of the Board. The meeting was called to order at 10:06am. Pledge of allegiance said by all.

Motion made to accept the agenda was made by Phil and seconded by Keith.

Treasurers Report – Linda reports the current balance in our checking account is \$17,820.95.

Discussion on how do we handle the money for the scholarships. There is no tax liability until we get into big money. Linda & Ray think we should keep the money in a regular account. Discussion on whether we want a separate account for the scholarship money from checking account. Keith & I think separate account is best. Linda would have to check in CD's and their payout and what a money market pays out. Linda will get back to us about should we have a separate account.

Linda stated we made a \$50 donation in memory of Scott Lindeman to the Kathy-Katy Lindeman scholarship.

Scholarship Report - Maybe we co-name the scholarships to future winners, the Bruce Bishop-William Harvey scholarship. We will table discussion on this until the next meeting. In February word will go out to retirees and current WSP employees. The criteria for the scholarships will remain the same as last year.

Merchandise Report – Ruth says we have 19 shirts, 118 silver coins, 41 travel mugs and 175 decals left.

Minimum order for challenge coins is 100. Motion by Dace and seconded by Ray to order another 100 gold coins. We will wait to order more medium t-shirts.

Linda makes a motion, seconded by Ruth to give scholarship winners a t-shirt.

Meeting started at 9:55 am at the WI State Patrol Wausau Post Pledge of Allegiance was recited by all.

Attendees: Pres. Mary Sander, NW Region Rep. Keith Young, Vice President Phil Wenzel, NW Region Rep. Ruth Tiry, Treasurer Linda Woldt, NE Region Rep Lyle Sconzert, SW Region Rep. Dave Collins and Secretary Kim Hurley.

Motion made by Linda and second by Ruth to accept the meeting agenda.

Mary shared the story of the Postmaster in her area making a \$300 donation to our scholarship fund. We are sending him a card and offering to make him an honorary member. Mary is also giving him a WSPAA challenge coin and WSPAA decal.

We are not making phone calls to solicit donations for our scholarship fund.

What should the donation amount be for the free gift? Discussion by all those in attendance. Keith suggested \$50, Phil suggested \$10, Ruth, Linda, Lyle and I suggested \$25. Motion made by Linda and second by Keith to make the minimum donation \$25. Linda will issue a receipt to the donors for tax purposes.

Linda will keep a spreadsheet of those who made the donations and their amount. This spreadsheet will be kept in house among the board only. However, we will mention donor names and <u>names only</u> in the quarterly newsletter.

I will put something together and send it out to membership announcing this scholarship fund and the opportunity to make donations.

I have been in contact with Centurion about gold coins and money clips. Discussion on the money clips and whether to pursue them. Consensus is not pursue them.

Treasurers Report – Linda reported we have \$17,680.67 in our checking account. Discussion among board members on money set aside for the scholarships and should we put it into a money market account or a CD. Currently CD's and money markets pay less than 1% interest. Mary suggests we have separate savings account for the scholarship money in order to keep monies clear should there be an audit. We bought 3 CD's each for \$2,000. They are a 6 month, an 18 month and a 24 month CD. \$400 was put in savings for now. As donations come in they will go into the savings account.



Merchandise report- Ruth reports that we have 255 decals and 118 silver challenge coins, plus a few t-shirts.

Scholarship Report - I spelled out the timeline for scholarship in 2022 and will have Diane King put it on our website. Timeline is as follows; announce the scholarship in February, application packets due end of April and winners announced in July.

Membership Report – Mary says we currently have 263 members. Renewals will start coming in as Kim keeps making the announcements to the membership through weekly emails.

Regional Rep. Reports - Lyle says they are not yet meeting in the NE Region. Those in the Green Bay area gathering are not interested in meeting at this time due to Covid. Dave – Mary A. puts out regular report on the green lantern breakfasts. Keith – Mary Sanders brother John Heffernan retired from the Patrol recently. Leaving no Heffernan's of that line in the WSP anymore. From 1957 until 2021 there was always a Heffernan from this family in the WSP.

Nominating committee – Nobody responded to my email showing any interest in running for Vice President or Treasurer. Following the by-laws Phil is appointed as the Vice President and Linda is appointed as the Treasurer by the President.

The nominating committee does not have to be board members. Keith was appointed by President Sander to be in charge of the nominating committee.

Audit committee – does not have to be made up of board members. Mary prefers that it be at least 2 people from the SW Region. This will be tabled until our next board meeting.

Round table – Phil would have no problem asking businesses in the Dells area for donations for our scholarship fund. Linda asked about alumni day for 2022, and asked Mary if she had contacted the Academy yet about it. Mary said she had not, but would before the next board meeting.

Lyle said District 3 is moving due to the highway expanding to 6 lanes. This includes moving the scales. This project will start in 2025.

Next meeting – March 22, 2022 10 a.m. at the Wausau Post. Motion to adjourn meeting was made by Lyle, second by Phil. Meeting adjourned at 1:27 p.m.
