President's Sanders' Thoughts



Your WSPAA Board members have traveled to a variety of States across the Country; many of those States have signs honoring police officers that have died in the line of duty. I have often wondered why Wisconsin didn't have any. The Board has discussed this in the past, but when we did the research, it seemed that it was an impossible task. Two tragic events happened in northwest Wisconsin, on April 8th, 2023, a Chetek police officer and a Cameron officer were killed during a traffic stop on CTH SS in Barron County. A portion of CTH SS has been renamed Officer Emily Breidenbach and Officer Hunter Scheel Memorial Highway. On May 6th, 2023, a St. Croix County deputy was killed on STH 128 in St. Croix County during a traffic stop. A portion of STH 128 has been renamed Deputy Kaitie Leising Memorial Highway.

We formed a committee in 2023 to revisit trying to get memorial signs for WSP Troopers Don Pederson, Gary Powless, Deb McMenamin, Willy Schoenberger, Jorge Dimas, Trevor Casper, Anthony Borostowski, and Daniel Stainbrook. The committee members are David Collins, Ron John Wolfe, Ruth Tiry, Paul Matl, Anne Maxson and me. In February 2025 each committee member reached out to Senators and Representatives from their area to seek support on drafting a bill. Senator Rob Stafsholt, who was instrumental in getting the memorial sign for Kaitie, agreed to take the lead.

We have had tremendous support from DOT Secretary Boardman, WSP Superintendent Carnahan and Colonel Fish. The WSP has started to notify the eight families of our fallen Troopers. The families will have the choice as to where the signs will be erected; this will give them the option of where the incident happened, a highway near their hometown, or place of burial. Many of Wisconsin's highways are already designated as memorials to groups, we aren't looking to rename them, but the plan is to have two signs approximately one mile apart in both directions to dedicate to our fallen officers.

Our next step is to get the Bill passed in both houses by the end of 2025 and we hope to stagger the installation of the signs throughout 2026.

Keep your fingers crossed that we can get this done now, as it should have been done long ago.

Carnahan gave a box of badges that were at Hill farms to Dave C. Dave asked Pete Hill to think of display tags we could use in the museum to identify people or objects.

4-22-25 History Committee Meeting at the Academy


Present Kim Hurley, Dave Collins, Mary Sander, Anne Maxson and Pete Hill
